Our Mission



Vision

A state where all babies have access to human milk.

Mission

To promote, protect, and support breastfeeding in Oklahoma.

Why It's Important

- Of Oklahoma's 77 counties, **58 are lactation care deserts** meaning a county with no Baby-Friendly hospital and no International Board Certified Lactation Consultants (IBCLC) available for clinical lactation care either in the hospital or in the community.
- Only **78% of Oklahoma babies are exclusively breastfed at birth**. National average is 84.1%.
- A recent CDC study of over 3 million U.S. births found that ever **breastfeeding is associated with a 26% reduction in the odds of post-perinatal infant death**.
- **The American Academy of Pediatrics recommends** infants be exclusively **breastfed for about six months** with continued breastfeeding while introducing complementary foods for two years or beyond.

Our Partners



Programs

Breastfeeding Friendly Childcare Designation

COBA is pleased to introduce the Oklahoma Breastfeeding Friendly Child Care Designation Program. With many Oklahomans returning to work or school after birth, quality child care that supports breastfeeding is of utmost importance. Being a recognized Breastfeeding Friendly Child Care site shows parents and the community that the program follows national breastfeeding and infant feeding standards. It lets everyone know that a childcare facility is committed to helping families give their children the best nutritional start they can – with breast milk!

Model Hospital Care Policy

With the recognition of breastfeeding as a public health issue, the encouragement from professional medical organizations for new mothers to breastfeed for 2 years or as long as desired, and with an increase in breastfeeding rates across the country, it is extremely likely that a lactating mother may be admitted to any area of the hospital. It is imperative that lactation be supported during any maternal or infant hospitalization, as it has both short and long-term effects on the physical and mental health of the woman and child. COBA has therefore created a Model Hospital Policy for Care of the Readmitted Lactating Patient. This policy guides hospitals in the care of lactating persons no matter what facility or hospital service they may be admitted to. In addition, we have created a patient handout, Preparing for Your Hospitalization or Procedure While Breastfeeding. We are happy to announce that this helpful patient handout is now available in Spanish.

Worksite Designation

COBA, OSDH and OBRC recognize 315 workplaces for adopting policies that support breastfeeding employees. Please encourage your worksite and others in your area to apply for recognition and contact us for assistance or questions.

Baby-Friendly Hospitals

This initiative acknowledges that breastfeeding is a biological norm and that breast milk is the best food available for human infants. COBA is proud of the ten Oklahoma hospitals that have been designated Baby-Friendly.

Advocacy & Committee Work

Educational Video Series

COBA staff and committee members quickly evolved into producers, script writers, casting directors, and stylists in 2025 as they worked tirelessly to develop educational videos accessible to all Oklahomans. These videos aim to bridge the gap in rural healthcare access; made for the workplace, healthcare professional, and parent audiences. The videos address pumping concerns, fatherhood support, lactation support in the hospital, childcare facility support, returning to work, employer guidelines and infant feeding in emergencies.

Looking Back 25 Years

Our Founding

The Coalition of Oklahoma Breastfeeding Advocates (COBA) was founded as a grassroots organization in 2000. COBA members' dedicated advocacy for pro-breastfeeding legislation resulted in three major victories between 2004 and 2006. During that time, Oklahoma passed laws protecting the right to breastfeed in public, giving jury duty exemption for breastfeeding, and supporting working breastfeeding mothers by clarifying the right to use break time at work for milk expression and encouraging the provision of a private location, other than a toilet stall, for expressing milk. COBA would especially like to thank Becky Mannel, Linda Miller, Rosanne Smith, and Crystal Stearns for their hard work promoting these policies.

Pivotal Moment

Created Breastfeeding Works! brochure for employers, a Breastfeeding Website, and a model Worksite Breastfeeding Policy and breastfeeding room. 315 worksites are currently recognized for policies and amenities that serve breastfeeding employees. COBA assisted OSDH in its choice to include breastfeeding goals in the statewide obesity prevention plan. COBA and OSDH also collaborated to develop a Nursing Moms and Babies Welcome decal for storefronts to help breastfeeding women and their families recognize places that welcome them. COBA partnered with OSDH in 2006-2008 to publish Right to Breastfeed wallet cards in English and Spanish. These cards, updated and still in publication, include helpful information about breastfeeding rights in the United States and Oklahoma. WIC, COBA, and partners have also collaborated to create public service announcements that support breastfeeding. We give special thanks to Nancy Bacon and Rosanne Smith for their commitment to these successful programs.

COBA was fortunate to be one of the recipients of the Oklahoma Choosing Childbirth (CCB) Grant. This grant has allowed us to expand our staff and hire Sarah Devane as Grant Manager. With the CCB grant we have produced videos on breast pump selection, returning to work and fatherhood support. We also partnered with Oklahoma Citizen Advocates for Recovery and Transformation Association (OCARTA) to set up lactation rooms in their main facility and sober living homes. These funds will propel us forward through the next year as we grow these programs.
